# BANK OF BERMUDA FOUNDATION JOHN D. CAMPBELL ARTS SCHOLARSHIP 2020

Awarded annually. Its purpose is to provide financial support of BD\$30,000 per annum over a period not exceeding four years to a student who is proceeding with undergraduate studies in the arts on a full time basis outside Bermuda.

The Scholarship is specifically for candidates studying Visual, Performing and Applied Arts including, but not limited to: (a) Visual Arts - drawing, painting, sculpture, ceramics, printmaking, photography, video and filmmaking; (b) Performing Arts - dance, music, opera and theatre; (c) Applied Arts – architecture, industrial design, graphic design, fashion design, interior design and decorative art.
